The explosive growth of ISO 9000 during the last 10 years has greatly expanded the certification world. ISO 9000 has spawned a host of related standards, such as AS9100 for aerospace suppliers and TL 9000 for telecommunications suppliers. The automotive industry's QS-9000 quality system requirements has led to the development of a set of quality system requirements known as the Tooling and Equipment Supplement to QS-9000.

ISO 9000 has been updated in the past year with the release of ISO 9000:2000. This greatly revised version of ISO 9000 introduces a process management approach and eliminates the 20-element structure of ISO 9000's previous incarnation in favor of four major categories.
